4. STATEMENTS BY THE VICE-CHANCELLOR

The Vice Chancellor

- (a) welcomed new members to their first meeting of Senate
- (b) reported that the University's Access and Participation Plan had been accepted by the Office for Students (OfS) for a five year period. The team involved were congratulated as due to their diligence and attention to detail the plan had been accepted with very little iteration and was to be subject to light touch monitoring. The Vice Chancellor proposed that the plan feature as an agenda item at the next meeting.
- (c) reported on an OfS focus on governance and the role Senate and Council play in securing quality and standards. An independent member of Council would be in attendance at Senate meetings in future.
- (d) reported on the success of the NRP DTP which had been awarded £12 million over the next five years in recognition of the excellent training environment provided across the whole NRP.
- (e) reported on the opening of the New Science Building by Dr Jane Goodall on the 24th October.
- (f) informed Senate of his role as chair of the UUK Advisory group convened to support work to produce guidance tailored to preventing and responding to racial harassment and responding to the Equality and Human Rights Commission's report on racial harassment in higher education.
- (g) updated Senate on the work of the VC Taskforce on mental health which would feature as an agenda item at a future meeting.

8. AURORA EUROPEAN UNIVERSITY NETWORK

Noted

that the European Commission had invited bids from alliances of universities who aspired to develop bottom-up networks of universities across the EU to promote student mobility, a challenge-based approach to education, and to contribute to the international competitiveness of European universities.

Considered

a proposal for the UEA to join the Aurora EUN bid, and approve in principle the proposed mission statement and primary areas of focus for the application to be submitted in early 2020 (and commencing later in 2020, if funded) (A copy is filed in the Minute Book, ref. SEN19D007)

(Senate noted that the Aurora network had been initially established by UEA and the Vrije University, Amsterdam about 3-4 years ago and has had biennial meetings each year with a focus on social inclusion, societal relevance and the enemata of staff and students. The EU Macron Initiative provides an opportunity to formalise the network.

However, due to the rules of funding, there have been some changes with some original partners leaving Aurora being involved in more than one network, and some new ones joining. There has been one round of funding so far and the intention is for Aurora to bid in Round 2.

Senate were supportive of participating in the bid and of the mission statement. Members asked if the content of the bid could give more detail about the aspiration in relation to the involvement of students and the student experience, and also culture and languages. A paper setting out the shape, look and feel for Aurora in 3-5 years time and some examples of how it might be working was considered desirable.)
