# 18. MINUTES

### Confirmed

### Considered

A report from the Vice Chancellor regarding Senate's decision that there should be a civic event in the Spring to engage wider stakeholders in the development of the new UEA Plan. The Vice Chancellor reported on the University's engagement with local authorities on an individual basis since the last meeting which was creating a positive environment for the new UEA Plan. In light of this experience, the Vice Chancellor sought Senate's support in pursuing this objective now via smaller bespoke activities with local authorities rather than holding a single large civic event.

### 19. STATEMENTS BY THE VICE-CHANCELLOR

- (1) The Aurora EU bid has been submitted. A summary of the bid will be hosted on the Senate Blackboard site.
- (2) The situation remained uncertain as regards the Government's strategy for higher education. A new minister, Michele Donelan, has been appointed to a narrower Universities portfolio with research and innovation now the responsibility of another minister. Nationally, it was considered that universities

> needed to be alert to developments with the Augar Review, potential student number caps, reductions in maximum fee levels, differential fees, and the value for money agenda.

- (3) The VC is chairing a UUK national advisory group on racial harassment established following the EHRC report and as a follow up to the Changing the Culture work. The group's work will be published in June and the recommendations implemented thereafter. The OfS had commenced a consultation exercise on harassment and sexual misconduct setting out expectations they were expecting Universities to follow. With the local environment in Norwich having a significant impact on students the University has both a Councillors' Liaison Group involving local counsellors for wards with significant student populations and a Changing the Culture Implementation Group which includes representation from the Police, Norwich City Council and relevant local charities.
- (4) The industrial action by UCU was on-going. The dispute focussed on pay and conditions and also on pensions. The Vice Chancellor reassured Senate that everything possible was being done to protect students learning outcomes. He expressed his commitment to address the issues raised that were within his control whilst advocating for flexibility on both sides so a resolution could be achieved on those things that had to be agreed at a national level. Senate was reminded that UEA had become a living wage employer last year, which had increased staff costs. The pension dispute was complicated by the involvement of USS Trustees and the Pension's regulator. But Senate was informed that talks were progressing positively on all fronts.

### 27. UEA PLAN 2020-2025

#### Considered

a presentation on the activities associated with and the development of the UEA Plan from Chief Operating Officer, Jenny Baxter

(Senate was reminded of the changing environment in which the Plan was being developed and respond to, including: the general election, Brexit, concerns around climate and biodiversity, the demographic dip, the needs of new generations of students, research funding opportunities, new partnerships, new City vision and the coronavirus. Financially, the University had to respond to an OfS proposal for a 5% cut in teaching grant in addition to the challenges in recruitment and the financing of the capital plan designed to improve the working environment for staff and students. The work on establishing a set of UEA values was nearly complete. A series of Big Shift Days had been held to consider priority areas and how they might be tackled, the themes were: global, research, employability, staff, student, learning and teaching and sustainability. In discussion Senate noted the distinctiveness that being part of the NRP brought to UEA. The first section of the plan, on student success, would be going to Council in March with other sections following with a view to finalising the plan in June.

Senate was also reminded of the work that was already underway to enhance and improve the experiences of staff and students from ideas generated by the "Fixing the Basics" exercise).
